LETTER FROM THE EXECUTIVE DIRECTOR

Dear Friends,

One of the joys of preparing an annual report is that it gives us a chance to look back and to be thankful for all that has been accomplished. It is no secret that 2020 was filled with both opportunities and challenges. Things to celebrate include:

- We served 139 single-parent families with 248 children through our Selfpower Model and 130 more through our community help sessions;
- We onboarded 51 new families into our program;
- Because of the generosity of our community, we were able bring more than \$80,000 in housing related supports to keep our families in safe housing and utilities, and more than \$58,000 to cover vehicle-related expenses to keep them moving toward their goals;
- Our Scholarship Committee awarded \$141,450 to participants for the 2020-21 school year;
- Despite enormous challenges due to the COVID-19 pandemic, we still had 9 successful program exits, 7 who were employed are time of exit; 6 Bachelor's degrees; 5 Associate degrees, and 1 certificate earned.
