LETTER FROM OUR EXECUTIVE DIRECTOR



Dear Project Self-Sufficiency Stakeholder,

Did you know that there are an estimated **2,410** single moms and dads with children under 18 living in poverty in Larimer County? And that the cost of living in Larimer County today requires that a single parent with two young children working minimum wage employment work 132 hours per week in order to survive without public assistance? Education is the basic premise of our work, and research indicates that earning a Bachelor's degree can increase income from \$400 per week with a high school diploma, to over **\$900 per week**. Our model proves this. There are other programs that support specific pieces needed to put the self-sufficiency puzzle together. What makes Project Self-Sufficiency unique is the fact that we pull all these pieces together, and combine them into an empowering case management model to support single-parent families pursuing career goals from start to finish. We get the job done and we are effective because of our model, our people, and our partners. **Thank you** for your interest in our work. 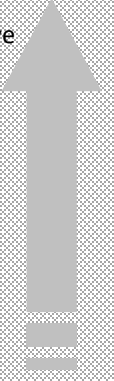

PROGRAM MODEL

30 years of service to over 1,000 single-parent families living in poverty has taught us that the most effective way to positively change a family's income is to provide intensive support to adults ready to pursue education and training opportunities and build career pathways. We begin by meeting each family where they are currently at in their journey and partner with them to stabilize their situation. This can include securing health insurance, housing, transportation and child care as well as resolving legal issues, physical and behavioral health challenges, and family safety. This period of stabilization empowers parents to focus on future education and career goals. Next, we provide tools and resources for each parent to create and pursue a realistic career plan that promises long term financial stability for the family. Along the way we have identified the many barriers that single parents face when trying to complete education programs or secure employment, so our model has built in resources to remove these barriers like car repairs, affordable housing, and academic tutoring and scholarships. Finally, parents are provided with tailored career placement services to secure that first job on their career path. Our goal is to move single-parents from making \$14,500 a year to \$56,887 a year to be self-sufficient.

In 2015, we made a commitment to eliminate our long waitlist and better meet the needs of program applicants. We now offer weekly walk-in help sessions so that single parents interested in our program can come in and learn about our model, meet our staff, and discuss immediate needs. We provide referrals to other community resources and help applicants prepare for our interview process.

Project Self-Sufficiency empowers Participants to make educated career decisions using a proven model and the latest tools to develop a realistic career plan.

- ▶ **Career Assessments** to learn about personal career skills, interests and values

- ▶ **Self-Sufficiency Wage Calculator** to determine the income each family needs

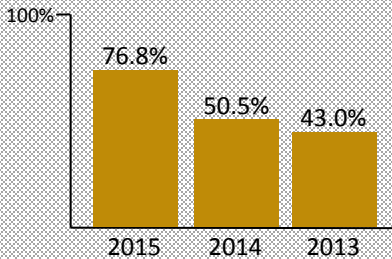

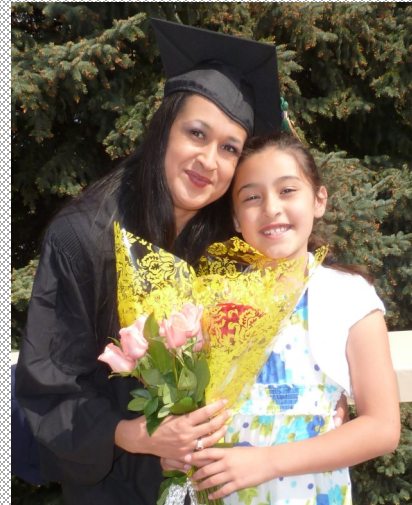

JOIN US IN PAVING CAREER PATHWAYS...

Today, single-parent families in Larimer County are faced with challenging times. A highly educated workforce means that the resumes of moms and dads with high school diplomas or GEDs are left at the bottom of a pile for jobs that pay better wages. Parents who work in low paying jobs are then confronted with rents that top \$1,200 per month for a two bedroom apartment and child care costs for an infant that can exceed \$1,400 per month. For families that cannot afford a car, public transportation is inadequate as they try to get children to daycare or the doctor, buy groceries, do laundry and get to school or work on time. When these same parents decide that earning a certification or degree is their pathway out of poverty, they often rack up student loan debt that leaves their family surviving paycheck-to-paycheck. Many families also face challenges such as learning disabilities and health concerns that impact the achievement of education and career goals for adults and impact growth and development for children. At Project Self-Sufficiency, we support families in each of these areas and many others, so that they can chart a sustainable career path and create a vibrant future for themselves and their children.
